


# Instructions to upload your paper


1. Log in to EasyChair. If you do not have an EasyChair account, please click on “create an account”.




2. Click on “I’m not a robot” (step 1) and Continue.




3. Complete the form (step 2) and Continue.




- You will receive an email to confirm your new EasyChair account. Please follow the instructions.



- Once you click on that link, you need to fill out the final form to create the EasyChair Account.




- Now, you can log in to EasyChair with your username and password created.
